Kern County (Delano/McFarland): **OFM** – Biofix 3/1, 256DD as of 3/28. **PTB** – First rap catch 3/24. **CRS** – First trap catch 3/24. **SJS** – Biofix 3/18, 88DD. **OLR** – Biofix 3/14, 145DD.

Tulare County (NE Kingsburg area except where noted): **CM** (Visalia walnuts) – A few moths trapped. Biofix not set yet. **OFM** – Biofix 3/11, 235DD. **CRS** (Visalia/Exeter) – A few scale trapped. Biofix not set yet.

Madera County: **OFM** - First moths trapped 3/16. Biofix 3/22. **SJS** – Scale parasites in traps. **OLR** – Biofix 3/22.

Merced County (Ballico & Winton areas): **CM** – A few moths trapped last week in apples. **OFM** – Biofix 3/14, 176DD. **PTB** – None trapped.

Sacramento County (Delta area): **CM** – No moths trapped as of 3/26. **OFM** – A few moths trapped 3/15.

Yuba County (Marysville): **CM** – No moths trapped as of 3/26. **OFM** – First moths trapped 3/5

Butte County (Gridley): **CM** – No moths trapped as of 3/26. **OFM** – First moths trapped 3/15

MARCH: CM, CM-DA COMBO, DA, CM 10X, CRS, DBM AND PTB traps should be set.
